
The Girl Sleuth and the Shadow of Crime: Exploring Female Crime Narratives in Children's Literature

Abstract

The paper explores the development of girl detectives in mid-20th century popular fiction from the Nancy Drew series (1930) by Carolyn Keene, Judy Bolton series (1932-1967) by Margaret Sutton, to the Trixie Belden series (1948) by Julie Campbell Tatham, as well as the Anne of the Famous Five series (1942) by Enid Blyton. These are stories of adventure for young readers but also a bit of revolution, in that the roles played by the female characters are ones that are normally reserved for the males: intelligent, courageous, and just detective. These characters don't only solve mysteries, they discover themselves. They are exposed to locations that are usually "danger" or "adults only" (e.g., crime scenes, clues and investigations) and questions of identity, safety, and independence. This suggested paper addresses issues of justice, gender roles, responsibility and how being a detective assists girl sleuths in understanding the world and their role in it. The genre becomes a space where young girls are allowed to take charge, ask questions, and build confidence, even in the face of uncertainty or fear.

Children's crime fiction is a growing genre, its roots lie in Victorian novels' depictions of children and childhood, though earlier works like fairy tales contained only nascent elements. This emerged as a distinct genre during the Victorian era. With the works of Charles Dickens like *Oliver Twist*, Fagin a young pickpocket blend seamlessly into the London streets precisely because he is young. Children's innocence and youth shield them from suspicion. This theme of using children's natural invisibility or being overlooked by adults became a central idea in later children's crime fiction stories.

Mark Twain showed this idea in *Tom Sawyer, Detective* by showing that children were clever and solved problems more effectively than sluggish adults who often make ineffective strategies. The story is told by Huck Finn who joins Tom Sawyer on the adventure. The story satirizes renowned detectives like Sherlock Holmes and shows how a child's curiosity and simple way of thinking can be even better than the clever tricks of great detectives. Although the book was meant for adults, it shows how adults frequently overlook crucial details. The sharp eyes of the child detectives help point out what the adults fail to see.

This idea continues in Anthony Horowitz's *Diamond Brothers* series. In books like *The Falcon's Malteser*, Horowitz uses humour and references to adult crime fiction. The role of detective is played by children even in the first of Sherlock Holmes novel which was *A Study in Scarlet*. Holmes uses the Baker Street Irregulars where a group of street kids to follow suspects. He says they're more useful than the police because they can go unnoticed and gather information easily.

From *Oliver Twist* to *Enola Holmes* and even in cartoons like *Scooby Doo*, young detectives use their invisibility and innocence as their strength. Dickens's has portrayed children as kind and honest in a harsh adult world which inspired the rise of children's detective or crime fiction works in the early 20th century. These stories gave kids a way to explore and understand adult issues while staying true to their own world and true self.

Edward Stratemeyer, an American writer has played a crucial role in developing the market for children's crime and detective novels. He has written about 150 books himself under different pen names. What's more is that he was the brains behind the Stratemeyer Syndicate, a team of writers who wrote some of the most well-known kids' detective stories. *The Hardy Boys* and *The Nancy Drew Mysteries* are famous amongst them. The original *Hardy Boys* series is thought to have been written solely by Stratemeyer himself. This series set the tone for many detective stories for children that followed.

'Stratemeyer made sure to incorporate current trends, such movie-going, into his series and kept them up to date with current technologies' (Greenwald). The *Hardy Boys* series became hugely popular, although some critics claimed it had a negative effect on children's thinking. Still the books did a great business and gained immense popularity. These were revised over time, and even turned into TV shows. "Stratemeyer's fiction depicted freewheeling youth who lived in the present and sported such contemporary items as motorboats, automobiles, motorcycles, or ... airplanes" (Billman) later books of Edward Stratemeyer include ed these technological innovations.

Crime stories for young readers further flourished in the 1920s and 30s. Meanwhile an exciting new medium came into existence in the form of comic books. Young readers were attracted to these books very much. Europe had *Tintin* as a young detective hero, meanwhile America developed iconic superheroes like *Batman* and *Superman*. Boys had their own masculine heroes like the *Hardy Boys* and comic book characters, *Nancy Drew* reigned as the leading female detective in the 1930s. *Nancy Drew* provided female readers a model of young womanhood combining traditional femininity with resourcefulness, strength, and remarkable

ability. With *Nancy Drew*, a new genre emerged: the female crime narrative, with various other girl detectives taking centre stage.

Nancy Drew, as the leading series established the teen sleuth as an iconic figure and role model for young readers (Reid-Walsh and Mitchell 445). The series premiered in 1930 with *The Secret of the Old Clock*. Written for the Stratemeyer Syndicate under the pseudonym *Carolyn Keene* by Mildred Wirt, the story launched a series that continued until 2003, eventually comprising an impressive 175 novels. Additionally, 34 revised versions of earlier titles were produced primarily to modernize the content and tone. The publishing responsibilities were shared over time firstly with Grosset & Dunlap who handled the first 56 volumes and the revised editions as well. Simon & Schuster took over and printed the rest of the volumes.

Later on a well-known continuation called *The Nancy Drew Files* was launched and it ran from 1986 to 1997. It gave readers a slightly older and more romantic version of Nancy who was still solving mysteries. In 2003 the original mystery stories series was ended by Simon and Schuster. Later on, a new series began in 2004 called *Nancy Drew: Girl Detective*. This version had portrayed Nancy teenage who was not always perfect and had interests beyond solving mysteries. Although the series brought a fresh storyline still it ended in 2012. In 2013 a new chapter began with *Nancy Drew Diaries*. This series continues to explore Nancy's adventures using modern storytelling and themes that connects more with today's readers.

Mildred Wirt Benson who first wrote as Carolyn Keene played a major role in making *Nancy Drew* successful in the beginning. She wrote 23 books of the first 30 volumes starting with *The Secret of the Old Clock* in 1930. Benson showed her as a girl who could solve mysteries better than most adults. Benson was able to prove she was the type of teen that drove her own car, chased the clues, and didn't ask anyone beforehand. By 1959, when the Stratemeyer Syndicate founder Edward Stratemeyer passed away, the writing of *Nancy Drew* was passed on to his daughter Harriet Adams. She led a major revision project of many of the early novels. These weren't just small updates to the language or social values but in many cases the whole story was changed while keeping the original titles. Along with these changes Nancy's character also went through a noticeable transformation. Adam has been re-embodiment Nancy as a quieter and more "feminine" personality than he was in the past, and more sophisticated and traditional. This shift is sometimes referred to as "More gentle than daring" (Mary) "polishing" Nancy's edges, and bringing her into closer accord with the expectations of mid-20th-century "American girlhood."

Together, Benson and Adams, and the other writers, left a legacy for the future. They paired the new with the old and produced books that would hold readers and paved new territory for women characters in books. Their combined writing as Carolyn Keene brought *Nancy Drew* to life as a good girl, smart, bold and capable young detective, there's plenty of time for shopping, discussing weight, and talking about boys, but not enough to forget the mystery. There is a small core group of friends to each novel, a problem solved, and a satisfying ending to each story at the end of each novel. (Mary). She was a role model for young girls without surrendering her girly qualities and was the inspiration for many more stories with strong female characters. *The Carolyn Keene* story is not about one writer's dream and vision, but rather the power of teamwork and collective imagination.

Nancy Drew has proved that young girls can be clever strong and fearless. From the first story in 1930 she became more than just a character and grew into a cultural icon. 'It is her unchanging qualities, her strength of intelligence and character, her persistence and resilience, and her unflagging sense of right and wrong, which make her both a cultural icon and a suitable subject for fanfiction.' (Merrill). Girls saw a role model in Nancy as she solved mysteries with confidence and never walked away from any challenges. The stories of Nancy not only gave us entertainment but they also helped the readers to think for themselves and believe in their own abilities. Her courage and determination towards work made the girls believe that they could also step outside of their assigned traditional roles and be the leaders of their own lives. At a time when strong female characters were rare *Nancy Drew* stood out. She wasn't afraid to speak up to take risks or to go after the truth. Her example helped shape the idea of female empowerment and encouraged girls to see just how much they could achieve. When she says "Read read read. That's all I can say." she is sharing the secret to confidence and courage. Her stories teach that knowledge leads to strength and every girl can be her own hero As Melanie Rehak notes Nancy became a symbol of what girls could do if they faced the world with boldness and belief in themselves.

Nancy's character and adventures are timeless and have kept her in readers minds. She is intelligent, brave and independent – they are always in fashion. The world has evolved and her stories have evolved with it and so each new generation has something to relate to. Her adventures have affected people in so many ways, the books, movies, games! At the heart of it is her enthusiasm for being true to herself and a fearless spirit; these are enduring messages that readers will continue to connect with her. Readers look on her as a character and not merely a character; a role model of courage. With such a loyal following of fans, *Nancy Drew* is not just a character but a symbol of courage and curiosity that continues to be passed down from generation to generation.

Nancy Drew is more than just a book. Her influence is all around in film, television, fashion and even academic research. Her legacy also has led to learners and authors' classrooms discussing gender roles, gender identity and empowerment. The legacy of *Nancy Drew* is evident in shows for young people, such as detective dramas featuring female protagonists, but it's also felt in young adult books that feature feisty female characters.

Nancy Drew is more than a book. Her influence is all around in film, television, fashion and even academic research. Her heritage also has led to discussions about gender roles, identity and empowerment in classrooms and in literary circles. The impact of *Nancy Drew* can be clearly seen from detective shows with smart female leads and also in young adult novels with fearless heroines. In *Girl Sleuth*, Melanie Rehak brings to light Nancy Drew's surprisingly far-reaching impact. Bobbie Ann Mason, on the other hand, in her book *The Girl Sleuth: A Feminist Guide*, has written with great admiration and a light tinge of challenge to the ideals portrayed in the entire *Nancy Drew* series. While celebrating the tradition, Mason also challenges the structures that have come before Nancy Drew's stories, and uncovers her own worries about the complicated relationship between power and gender in these tales (Mason).

Nancy Drew's influence can also be seen in the works of many other Children detective fiction Novels as many writers took inspiration from Nancy Drew. Judy Bolton another girl detective series came in the 1960s and gained immense popularity. Judy Bolton was Margaret Sutton's brainchild, all written by herself with no team involved from 1932 to 1967. Judy starts solving mysteries at the age of 15, her life goes on she grows and gets married but continues her detective job of solving mysteries. Sutton's 38 books are known for strong writing and clever plots. She paid attention to real life issues like race, class, and all the things that often goes unnoticed. These qualities set her stories apart from the other children detective stories.

Judy Bolton features powerful plots and strong morals. Judy's story has multiple layers of meaning for scholars found in its character and in the stories. She was more than just a girl solving mysteries. She was someone who questioned unfair world and refused to accept the restrictions placed on her as a girl. The stories are often highlighted serious issues like unemployment, unsafe working conditions, class divisions, and the quiet struggles of ordinary people. The readers noticed how one person's empathy could lead to real change with help of Judy Bolton.

One powerful moment is there in the series is when Judy organizes a costume party where nobody knows who belongs to which social class. This scene connects closely to Mikhail Bakhtin's idea of the carnivalesque (Bakhtin 10) where social structures are briefly turned upside down and everyone exists on equal ground. It makes a space where there are no usual

roles and divisions are faded away and the people are freely interacting without passing judgments. The books have no direct mention of the Great Depression still we can feel a slight effect of that time. Judy's actions show that justice isn't impossible and that sometimes kindness and courage are can be one of the sharpest tools in solving a mystery and get justice in life.

The character of Judy Bolton is not only admired by readers. It made a very positive impact on the writers as well. Judy Bolton inspired later detective fiction writers too. Linda Tracy, after being influenced and very impressed by Judy Bolton compiled the Guide to Judy Bolton Country which was a detailed book containing all aspects of the Judy Bolton books big or small. While on the other hand Marcia Muller a famous detective writer who is famous for her female detective character Sharon McCone from her Savvy series accepted that Judy Bolton was her most loved teen girl detective character because as Judy was realistic, practical and independent. She further has accepted that her own character of Sharon McCone has been inspired by her. (Muller)

Later after the World War 2 ended the comic culture emerged in America with full swing. Comics were loved by everyone be it a kid or an adult all liked reading comics. We assume after the great depression and World War 2 the people wanted to take a break and read something lighter and their wish was fulfilled by the American comics. The comics had quick paced plots which took the readers away from the traditional novel culture. One of the comic series that emerged was that of a girl detective by the name Trixie Belden. The Secret of the Mansion, published in 1948, marked Trixie Belden's first appearance. It was created by Julie Campbell Tatham in opposition to Nancy Drew. Trixie Belden character is noticed to be childish and a bit timid at times than *Nancy Drew* who was more strong, mature and brave.

Talking about detective narratives we cannot skip the very famous Enid Blyton's first Famous Five series of book. Blyton is best known for the Famous Five Series and all other children's crime series and detective works. The Famous Five are comprised of the siblings Julian, Dick, and Anne, their cousin George, and her dog Timmy. These 5 like the other children detectives we have discussed are free from adult supervision and have freedom to explore all mysterious locations, haunted castles and what not. Talking about female detectives we will talk about the female characters, Anne's role in the series and that of Georgina, known as George.

George is actually Georgina and she is one of the most complex and memorable characters in Enid Blyton's Famous Five series. She wants to be called George and she often refuses to answer to her real name. 'George is her constant battle to prove she's "as good as any boy," to the point that she dresses as one, cuts her hair short, and calls herself George rather than Georgina'

Robinson). George is a greatly complex character. She has a hot temper which she learns to control over the time gradually as the 21 books progresses. But under her tough appearance, George is full of emotions, especially toward her dog Timmy and her cousins. Like Nancy Drew, George steps into a space where girls were rarely allowed. She is solving mysteries, facing dangers, and leading the operations. However, unlike Nancy who remains polished and composed, George is wild, moody, and sometimes even reckless. George shows boyish traits like bravery independence and a strong dislike for rules but underneath that she has deep feelings and affections All through the series she pushes against the usual idea of what a girl should be not because she wants to stop being a girl but because she proves that things like courage strength and leadership belong to anyone not just boys.

Anne is the youngest character of Enid Blyton's Famous Five series, Anne has the role of the detective helper, and she doesn't have a dominant role in solving mysteries or detective work. Instead, she is often seen helping the detectives in domestic duties during their adventures and is sometimes shown as little sensitive than the others. Her role is more focused on helping and refining the lives of her detective friends for smoother operations. In *Five Have a Genderful Time* Rudd notes –‘Nancy Drew’s way of solving mysteries expresses who she is and reflects her personality. Unlike Anne, who fits the traditional quiet and feminine role not being able to fully express her as she is seen bound’ (Rudd).

Anne is noted to have all the qualities every man looks for in a woman, and everything that women disdain today. Anne hates adventures. ‘Anne is perhaps the crème de la crème of Helpless Pathetic Girls, the one who other like-minded girls look to as a model of wimpiness’ (Robinson). Anne may have started as the youngest, but can be quite brave sometimes, and ‘Anne even has moments where she rears up like a tiger and puts little boys in their place as seen in *Five Have a Mystery to Solve*’ (Robinson). Though she hasn’t been seen chasing villains or solving mysteries much like the others still her emotional strength, quick instincts, and kindness evolve into her own kind of power. Anne teaches us that bravery isn’t always loud it can be gentle, thoughtful, and fiercely loyal.

By the late 1930s, crime stories had become a big part of children's books. Girl detectives like Nancy Drew, Judy Bolton, Trixie Belden and George and Anne from the Famous Five were not just characters in fun adventures. They were curious, brave and determined. They questioned, stood up for their beliefs and were not bound by the rules of the society. These girls took no orders. They assumed responsibility and pioneered the way. Girls were given the message that it was acceptable to stand up and be brave in their stories. It's portrayed that bravery and intelligence were not limited to the boys. This shift in storylines was like the real world too. Following the image of women in the Victorian era, which was strict and silent, things began

to change. Gaining independence, women began to express their opinion and to live according to their own way. These girl detectives were signs of that change. They showed what it meant to be strong and thoughtful and full of questions. Their stories gave young girls hope and confidence. They were more than just fun reads. They helped girls imagine a world where they could be the heroes too. These stories have helped us understand the female narratives in Crime and Detective literature for young learners.
